



. Geographical Location



Located on China's southeastern coast, Fujian is one of the country's main gateways to the Asia-Pacific region.



. Logistics and Transportation



The four major costal ports of Fujian are the Ports of Xiamen, Fuzhou, Meizhou Bay, and Quanzhou. The cargo throughput of each of the former three ports exceeds 100 million tons. Fujian has container shipping routes reaching over 140 ports in more than 50 countries and regions.

In 2023, Fujian had total operating railways of 4,722 km. The density of the railway network is twice the national average and a closed loop of inter-city express railway has formed.



In 2023, operational highways in Fujian reached 115,645 km, and a total expressway operating mileage of 6,169 km. 


As one of the earliest provinces to implement the reform and opening-up policy, Fujian has spearheaded opening-up in China. In 2023, foreign-funded enterprises accounted for approximately 1% of the total number of enterprises in the province and they were responsible for around 20% of the province's import and export volume and tax revenue, and roughly 10% urban jobs in its non-private legal entities. For industries above the designated size, foreign-funded enterprises' added value and sales output value account for about 25% of the total



... Human Resource

Fujian is home to 89 higher education institutions and has established 38 provincial-level industrial technology research institutes. There are 10 national key laboratories, 2 state key laboratories, 7 provincial innovation laboratories, 267 provincial key laboratories, 7 national engineering technology research centers, 527 provincial engineering technology research centers, and 220 modern provincial R&D institutions in the province. In 2023, 321,200 students graduated from graduate schools, universities, and higher vocational colleges in Fujian.

Continental Coastline

Fujian boasts the second longest continental coastline in China. The coastline, which is about 258 km in length, is a natural coastline suitable for building 10,000-ton and above berths, topping the whole country.

Forest Coverage





In 2023, electronic information enterprises above the designated size in Fujian achieved a total operating revenue of RMB 985 billion, a YoY increase of 0.5%, ranking 6th in China.

Advanced Equipment Manufacturing Industry

By the end of 2023, there were 4,623 enterprises above the designated size in the machinery industry (including automobiles and marine) in Fujian, including 419 large and medium-sized enterprises, with operating revenue of RMB 1163.74 billion and a total profit of RMB 95.529 billion, a year-on-year increase of 6.5% and 19.7%, respectively.

The petrochemical industry is mainly distributed in the "two bases and one special area" of (Meizhou Bay and Gulei Petrochemical Base, and Jiangyin New Chemical Materials Special Area) in Quanzhou, Zhangzhou, Fuzhou, and Putian and the Kemen New Chemical Materials Industrial Park. In 2023, the operating revenue of 1,042 petrochemical enterprises above the designated size across the province rose 5% over the last year to RMB 515.12 billion.

Fujian is a major province within the textile, footwear and clothing industries. It has formed a relatively complete industrial chain of chemical fiber, spinning, weaving, dyeing and finishing, clothing, home textile, industrial supplies, and footwear enterprises. In 2023, the operating revenue of the textile, footwear, and clothing industry in the province reached RMB 644.057 billion. Specifically, the operating income of the textile and clothing industry registered RMB 222.644 billion, and that of the footwear industry was RMB 239.956 billion.

Cotton Textile Weaving

We will focus on the development of cotton combed, blended, core-spun yarn, color spun yarn, and two-component and two-color yarn series of products. We will develop functional yarns of series and stock-solution colored chemical fibers, staple fibers, and filaments. This approach will accelerate the development of new functional clothing and industrial fibers to promote green chemical fiber raw materials such as biobased fibers and terminal products such as knitted textiles and three-dimensional-formed knitted fabrics. These products will be used in the medical and healthcare sectors as well as the knitting industries.

In the vanguard of China's seven strategic emerging industries, the new material industry is pivotal to the "Made in China 2025" initiative. It lays the foundation and holds the key for the transformation and upgrading of the manufacturing industry. The pace of development in the new materials industry in Fujian has recently accelerated and the industrial agglomeration effect has been enhanced. The innovation system has gradually improved and the variety of new materials has been enriched. Several enterprises, with strong reputations both domestically and abroad, have been cultivated, and new material products such as rare earth metals, tungsten, molybdenum, lithium materials, stainless steel, new materials, advanced textile materials, and advanced chemical materials have been established.

New Energy Industry

Fujian gives full play to its resource advantages and adheres to the direction of clean and low-carbon development. The province will develop new and renewable energy sources and build a modern energy system with the coordinated development of energy and ecological civilization. We will promote the construction of an important energy base along the southeastern coast and continuously enhance the level of energy security. By the end of 2023, installed power capacity in the province had reached 81.4138 million kilowatts from a diverse energy mix with 16.0624 million kilowatts from hydropower, 37.1699 million kilowatts from thermal sources, 11.6620 million kilowatts harnessed through nuclear energy, 7.6172 million kilowatts generated by wind, and 8.7453 million kilowatts from photovoltaic power. Clean energy sources notably constituted 63% of the total, reaching 51.31 million kilowatts, responsible for about one in every two kilowatts of electricity.

Biology and New Medicine Industry

Fujian's biology and new medicine industry is gradually expanding. The province has formed an industrial development pattern with Xiamen, Fuzhou, and Sanming as the main support, and the key regions are collaborating to promote this industry. Several key medicine industrial parks have emerged, such as the Fuzhou Jiangyin Industrial Park, the Fuzhou High-tech Zone Biomedical Industrial Park, the Xiamen Biomedical Port, the Sanming Biomedical Industrial Park, the Putian Cross-Strait Biotechnology and Medical Health Industry Cooperation Zone, and the Changting Medical Device Industrial Park. The Xiamen biomedical industry cluster has been selected as a national strategic emerging industry cluster. By the end of 2023, there were 341 pharmaceutical enterprises above the designated size in the province, with an operating revenue amounting to RMB 60.1 billion.

The China (Fujian) Pilot Free Trade Zone was launched on April 21, 2015, with an implementation area of 118.04 square kilometers, covering the three areas of Fuzhou, Xiamen, and Pingtan Comprehensive Experimental Area. Over the course of nine years, the China (Fujian) Pilot Free Trade Zone has remained steadfast in its commitment to institutional innovation as the cornerstone of its development, yielding numerous achievements marked by distinct Fujian characteristics and a Taiwan-first principle. Concurrently, it has methodically broadened its institutional openness, aligning with an institutional framework that resonates with globally recognized standards. Furthermore, it has expedited the nurturing of advantageous and distinctive industries, erected several influential, innovative development platforms, and fully leveraged its capacity as a comprehensive experimental hub for reform and opening up.





. Summary of Numbers



The China (Fujian) Pilot Free Trade Zone has launched a total of 622 innovative initiatives, of which 275 are the first of their kind within China.



These include 35 innovations that have been replicated and promoted nationally. 9 pilot experiences have been included in the "Best Practice Cases" of the national pilot free trade zones, firmly positioning us at the forefront of innovation.



A total of 131,000 new enterprises were added with a registered capital of RMB 2.84 trillion, a respective 8.5 times and 12.8 times those before the establishment of the Zone.



With less than one-thousandth of the province's area, the Zone has attracted nearly **one-quarter** of the province's new foreign-funded enterprises and contributed one-sixth of foreign trade import and export volume.

- At present, the Chinese name of the website, "Invest Fujian", and related keywords command prominent positions in the search rankings of Baidu and Google.



To implement the decision and deployment on foreign capital utilization of the Central Committee of the Communist Party of China (CPC) and the State Council, Fujian has introduced several policy documents to promote the utilization of foreign capital in recent years.

. Complaint Management for Foreign-invested Enterprises



Notes:

This procedure is based on the Rules on Handling Complaints of Foreign-Invested Enterprises.

- 1. "The complainant" refers to foreign-invested enterprises and foreign investors.
- "Complaints" include:
- (a) The Complainant alleges that their legitimate rights and interests have been infringed upon by the administrative actions of administrative bodies and their staff members;
- (b) The Complainant reports issues concerning the investment environment and suggests improvements of relevant policies and measures to agencies handling complaints.

The complaints do not include applications of the Complainant for coordination to settle civil and commercial disputes with other natural persons, legal persons, or other organizations.

- 3. "Agencies Handling Complaints" include:
- (a) The National Center for Complaints of Foreign-Invested Enterprises;
- (b) Departments or institutions designated by local people's governments at and above the county level that are responsible for accepting complaints of foreign-funded enterprises.
