



#### **FOREWORD**

The sun casts rays of illuminating light into the mind constantly;

The sea nurtures and nourishes growth and prosperitv incessantly.

Xiamen is situated on the western coast of the Taiwan Strait in the East China Sea. As one of China's first four special economic zones, Xiamen stands at the forefront of China's reform and opening-up. Specifically, Xiamen is a scenic international port city, a popular tourist destination and a strategically pivotal city on the 21st-Century "Maritime Silk Road". She was also the host city of the 9th BRICS Summit, praised by Chinese President Xi Jinping as "a leading city for innovation and entrepreneurship" and "an enchanting and ecological garden city".

In the past 41 years of reform and opening-up, Xiamen has seen an average annual growth of 15.2% in its GDP and 18.4% in its gross financial revenue. Today, Xiamen is a haven for creativity, innovation and entrepreneurship. The city leads the nation in terms of total economic output and financial revenue per square kilometer of land, per capita GDP and financial revenue, and foreign trade competitiveness. High-tech enterprises account for nearly 70% of the added value of the city's industry. Moreover, Xiamen is one of the nation's highestlevel comprehensive international transportation hub and top four international shipping centers. Its annual port container throughput exceeds 10 million TEUs, the 14th highest in the world, and there are 35 scheduled flights services to international destinations. In addition, Xiamen is the gateway to mainland China for Taiwan residents and businesses, and one of China's most business-friendly cities. Furthermore, Xiamen ranks first in the ecological civilization index of Chinese cities at the prefecture level and above, and its good air quality rate is the fourth highest in China. Xiamen has also won the title of "National City of Excellence in Civil Ethics" for five consecutive terms.

On April 29, 2019, we held the Xiamen Investment Promotion Convention, extending invitations to business people all over the world for win-win cooperation and common development in the city. Over the past year, Xiamen officials have worked untiringly and unceasingly to raise investment quality and efficiency and maintain the strong growth momentum. A series of business and investment promotion events have been staged, including

the "Triple-High" Enterprise Development Convention. the Financial Industry Promotion Conference, the Development Convention for the Cultural, Tourism and MICE Industries, and the New Economy Development Summit. Xiamen also rolled out competitive probusiness policies to ensure high-quality development and build a world-class business environment. The people of Xiamen all did their part, in ways big and small, for the creation of a super business environment. setting off a wave of inbound investment and economic development. Last year, a total of 2,383 investment projects were generated, with the top value topping RMB 1.2 trillion, and our GDP growth rate was the highest in five years, ranking first among the nation's 15 semi-provincial level cities. Moreover, our per capita GDP exceeded USD 20,000 for the first time, taking the city's development to a new level.

At present, guided by Xi Jinping Thought on Socialism with Chinese Characteristics for a New Era. Xiamen is making all-out efforts to implement new development concepts and is speeding up the establishment of a modern system of industries. The city is poised to become a glamorous global metropolis. 

## Geographic Advantages

### A Port City with a Long History

In his 1864 trade report, George Hughes, Commissioner of Customs in Xiamen, wrote: "Xiamen is the point connecting the Chinese market to the South markets." (Note: The South markets include present-day Thailand, Singapore, Malaysia, Indonesia and other Southeast Asian countries.)



Under the "Belt and Road" Initiative, Fujian is designated as the "Core Region of the 21st-Century Maritime Silk Road". As a major node of seamless connection between the Land and Maritime Silk Roads, Xiamen is set to become a strategically pivotal city on the 21st-Century Maritime Silk Road, serving as a hub for global connectivity, economic and trade cooperation, maritime cooperation and cultural exchange.

## A Major International Shipping Hub

Centrally located between Southeast Asia and Northeast Asia, the Port of Xiamen has direct links to 149 ports in 54 countries and regions around the world.

#### A Major Point of Access to the Sea from Mainland China

Xiamen faces the Taiwan Strait to the east, bordering the Pearl River Delta to the south and the Yangtze River Delta to the north. The city is also connected westward to Jiangxi, Hunan, Hubei and the vast hinterland along the Beijing-Kowloon Railway.

#### A Strategic Pivot for Exchange and Cooperation with Taiwan

Xiamen is the only special economic zone in mainland China which has been set up with Taiwan in mind. The city has been authorized to conduct comprehensive supportive reforms for the purpose of deepening the exchange and cooperation across the Taiwan Strait. Xiamen will be built into a cross-strait demonstration zone for integrated development and is on track to become the number one destination for Taiwan residents and businesses bound for mainland China.



As one of the nation's 12 highest-level "comprehensive international transportation hubs" designated by the State Council, Xiamen boasts superb sea, land and air transportation facilities, as well as a cruise port. Its international airport, seaport, expressways and railways facilitate the flow of passengers and freight. The city is a central transportation hub delivering seamless global connectivity with unrivalled operational efficiency and a full range of services.

Xiamen Airport is one of the six largest airports in mainland China. Citizens from selected nations who transit through Xiamen Airport are eligible for 144-hour visa exemption. Xiamen Airport has earned the platinum accreditation in IATA's Fast Travel Program and has been rated by CAPSE as the Best Airport of the Year for six consecutive years.

The Xiang'an International Airport, which is currently under construction, is expected to handle 85 million passengers a year. Slated for completion by the end of 2023, the new airport will be a major regional aviation hub on China's southeastern coast. a "gateway" hub airport on the Maritime Silk Road and a leading airport for transportation across the Taiwan Strait.

#### Advanced Shipping Hub

Xiamen is one of China's top four international shipping centers and the logistics center on China's southeastern coast. The Port of Xiamen operates 152 container shipping routes, including 101 international routes (69 routes to countries along the Maritime Silk Road). There are 175 operative berths (including 80 berths capable of handling ships over 10,000 tonnes). The Port of Xiamen is an integrated hub for direct transportation across between mainland China and Taiwan. The ferry services between Xiamen and Kinmen account for 20% of the passenger traffic across the Taiwan Strait. Last year, 1.82 million passengers were recorded, bringing the cumulative total to 19.69

#### Silk Road Shipping

Fujian Province is taking advantage of its standing as the core region of the Maritime Silk Road to build a "Silk Road Shipping" Alliance, formulate and promote the "Silk Road Shipping" service standards, and broaden cooperation with international ports. This initiative, with the Port of Xiamen at the core, is expected to transform Xiamen into a national center for not only "Silk Road Shipping" but also for China-Europe freight train services. Thus, the network of "Silk Road" shipping will be further expanded, and a great channel for sea and land transportation across the world will emerge to facilitate economic and trade cooperation and the flow of logistics between the East and the West. In December 2018, "Silk Road Shipping"-named shipping routes were officially launched in Xiamen. At present, 60 such shipping routes are in operation.

## TEUs handled

#### • Hub of Efficient Land Transportation

Xiamen is seamlessly connected to central and western China through the Shenyang-Haikou, Xiamen-Chengdu and Xiamen-Shaxian Expressways and other intercity rapid transit links. With the Yingtan-Xiamen. Fuzhou-Xiamen. Xiamen-Shenzhen and Longyan-Xiamen Railways, Shanghai, Shenzhen and Fuzhou are merely five, three and two hours away by train, respectively. At present, a high-speed rail link between Fuzhou and Xiamen and an intercity rail system that links up Xiamen, Zhangzhou and Quanzhou are under planning and construction.







#### Transit Rail System

Metro Lines 1 and 2 have opened, linking Xiamen Island to Jimei and Haicang. Metro Lines 3, 4 and 6, with a total length of 190.3 kilometers, are under construction. Based on the three links connecting the island to the mainland area, Xiang'an International Airport and Xiamen North Railway will provide air-rail combined transport and an efficient transit system will be in place around the bay.

#### Ohina (Xiamen)-Europe Freight Trains

Among the cities where China-Europe freight trains are available, Xiamen is the only land-sea hub city with seamless connections to the "Belt" and the "Road". International freight trains operate between Xiamen and Europe, Central Asia and Russia, reaching 34 cities in 12 countries. Sea-rail combined transport facilitates the flow of goods between Xiamen and Hong Kong, Taiwan, South Korea, the ASEAN countries and Europe, making Xiamen a hub on the three major logistics links between China and Central Europe, Central Asia and Russia.

#### **Education**

#### Educational Resources

- There are 1,429 full-time schools, including 18 institutions of higher education, 120 secondary schools, 296 elementary schools, 989 kindergartens, and six special education schools.
- In addition, there are three international schools for expatriates' children: Xiamen International School, Manila Xiamen International School, and Xiamen Concordia International School.



#### **Xiamen University**

Xiamen University (XMU) is part of Project 211, Project 985 and the nation's Double First-Class University Plan (the World First Class University and First Class Academic Discipline Construction Plan), three national initiatives aimed at elevating selected Chinese universities to world-class status. XMU's chemistry, oceanography, biology, ecology and statistics programs have been included into the nation's list of academic programs for world-class status. At present, 22 XMU professors are academicians of the Chinese Academy of Sciences and the Chinese Academy of Engineering. Reputed as the "pride of southern China" and "China's most beautiful university", XMU is the first Chinese university to establish an overseas campus (in Malaysia).

#### **Huaqiao University**

Huaqiao University (HQU) is directly affiliated with the Overseas Chinese Affairs Office of the State Council. HQU is a "high-priority university supported by the State" and part of Fujian Province's Double First-Class University Program. At present, HQU hosts over 5,000 students of Chinese descent from 40-plus countries and regions, students from Hong Kong, Macao and Taiwan, and students of foreign citizenship.

#### Jimei University

Jimei University (JMU) was founded in 1918 by renowned patriotic overseas Chinese leader Tan Kah Kee. JMU is one of Fujian Province's key institutions of higher education. The university receives support from not only the Government of Fujian Province but also the Ministry of Transport and the State Oceanic Administration.


## **Environmental Advantages**

#### **World-Class Business Environment**

Xiamen was one of the first Chinese cities to build a world-class business environment according to the World Bank's Ease of Doing Business (EDB) Index System. In the 2019 evaluation by the National Development and Reform Commission, Xiamen ranked among the top Chinese cities in terms of business environment, leading the nation in introducing innovative practices for issuing building permits and for tax services. Xiamen's social credit system has also steadily improved. In 2009, Xiamen's comprehensive credit index was the fifth highest among the 36 provincial capital cities and semi-provincial level cities in mainland China.

#### **Ecological Living Environment**

Xiamen is one of China's most popular destinations for international tourists, reputed as the "Garden on the Sea". In Xiamen, the average annual temperature is 20.7°C, and the climate is mild all year round. There are 150 parks and the green coverage rate reaches 45.1%. With a good air quality rate of 97.5%, Xiamen's integrated air quality index ranks fourth among the 168 key cities in the country, and its ecological civilization index is the highest among Chinese cities at the prefecture level and above.





#### Healthcare

#### Health Institutions

- © Xiamen boasts 2,111 medical and health institutions, including 63 hospitals, 2,005 primary-level medical and health institutions, 24 specialized public health institutions, and 19 other health institutions. There are eight Class A, Grade 3 hospitals in Xiamen, all of which offer medical services to expatriates.
- The city has 11 national-level key clinical specialties, including pediatric intensive care, gastroenterology, cardiology and ophthalmology.
- Xiamen residents' main health indicators are close to the average level of developed countries, and the average life expectancy among residents in Xiamen reaches 80.89 years.









## First Affiliated Hospital of Xiamen University

China's top 100 hospitals and China's top 100 HIC hospitals, accredited by Joint Commission International (JCI) as an HIMSS EMRAM Stage 7 Hospital (the highest designation) for both inpatient and outpatient care.

## Fudan University Zhongshan Xiamen University

One of the nation's first pilot regional medical centers, jointly built by Xiamen City and Fudan University and boasting two academician work stations and 12 "eminent doctor" studios.

## Xiamen Cardiovascular Hospital of Xiamen University

One of China's top 100 hospitals in terms of the Science and Technology Evaluation Metrics (Cardiovasology).

#### **Chung Gung Memorial Hospital**

The first Taiwan-funded Class A, Grade 3 general hospital in mainland China, ranked 14th in the 2017 Asclepius List of China's 100 Most Competitive Non-Public Hospitals.

#### **Xiamen Humanity Hospital**

A modern Grade 3 non-profit general hospital initiated by C&D Corporation and established by Benevolence Medical Foundation, boasting a large number of full-time senior doctors renowned nationally for their expertise.

## Sichuan University Huaxi Xiamen Hospital

Slated for completion in 2022 and set to become a leading regional medical center for complicated and critical illnesses, with plans to bring in at least five national-level key clinical specialties from the Affiliated Hospital of Sichuan University.

#### Cruise Tourism

Xiamen is one of China's top four pilot cruise ports, able to accommodate four large or medium-sized cruise liners simultaneously and the world's largest cruise ship, which has a gross deadweight tonnage of 220,000. In 2019, Xiamen received 136 cruise liners, the second highest number in China. "Gulangyu", China's first cruise ship with a homegrown brand, operates with Xiamen as its home port.

## **Key Industries for Development ○**



In light of its resource endowment and functional positioning, Xiamen focuses on developing five major industrial clusters: electronic information, equipment manufacturing, tourism culture, modern logistics, and financial services. The city sets its sights on building 10-plus industrial-chain clusters with RMB 100 billion in annual revenue, including flat panel displays, computers and communication equipment, semiconductors and integrated circuits, software and information services, mechanical equipment, new materials, tourism and MICE, cultural and creative industries, modern logistics, financial services, biomedicine and health, and modern urban agriculture. These industrial-chain clusters are set to enhance the comprehensive competitiveness of Xiamen's industries across the board.

Xiamen is one of the regions in mainland China where the TFT-LCD industry has grown by leaps and bounds, and the city's TFT-LCD industry is among the six largest in China. At present, Xiamen is the nation's only pilot city for optoelectronic display industrial clusters and the world's largest R&D and production base of global touch screen modules. In 2019, the output value of Xiamen's TFT-LCD industry reached RMB 146.5 billion, and several major projects were launched, including Tianma's

6th-generation flexible AMOLED production line, Nippon Electric Glass's Phase 3 electric nitrate glass substrate project, and TPK's wearable and 3D touch modules. A comprehensive industrial chain is now in place in Xiamen, covering every field from glass substrates, panels and modules to LCDs and complete machines. Representative enterprises include Tianma Microelectronics, Nippon Electric Glass, AUO, Darwin Precisions, AOC, TPK Holdings, TPK Touch Solutions, and Hongxin Electron-Tech.

Xiamen is home to many leading manufacturers of integrated products, such as computers, mobile phones, video conference systems, mobile phone lenses, micromotors, flexible circuit boards, Bluetooth and wireless access equipment, digital audio-visual equipment, and vehicle communication, positioning and navigation devices, sensors, etc. The city also hosts many supporting and industrial-chain extension enterprises producing basic components, accessories and peripheral devices and providing IT services. Xiamen's shipments of complete computers, servers

and monitors are among the highest in China, and the city's brands of complete computers are globally recognized. In 2019, the output value of the city's computer and communication equipment industry totaled RMB 125.7 billion. Representative enterprises include computer manufacturers Dell and Inspur; mobile phone and other communication terminal manufacturers Lenovo Mobile, Yealink and Yaxon Network; and electronic component makers Tongda, GSEO, Mektec, Hualian Electronics, Fuji Electric, Dial Electronic and TDK.

#### Development Foundation

Xiamen is home to over 300 enterprises in the semiconductor and IC industrial chains, covering everything from design and manufacturing to closed testing, and from equipment and materials to applications. In 2019, the output value of these enterprises totaled RMB 43.3 billion, making Xiamen the largest LED producer in China. There are three major agglomeration zones for IC enterprises – the Torch High-Tech Zone, Haicang Taiwanese Investment Zone, and the Huli Area of the Pilot Free Trade Zone.

The city's major platforms for this industry include Xiamen IC Design Public Service Platform, the National IC Shenzhen Industrialization Base Xiamen (Haicang) Base EDA Platform, and Xiamen IC R&D and Testing Center. Representative IC enterprises include Leadcore, San'an Integrated Circuits, Silan Microelectronics, Tongfu Microelectronics, Jaysun Semiconductors, Unisoc, Uxfastic and SigmaStar, and representative LED enterprises include San'an Optoelectronics, Changelight, Kaistar, Qiangli Jucai and Leedarson.

Xiamen's mechanical equipment industry covers five major industrial segments: large and medium-sized passenger vehicles, power transmission and distribution equipment, aviation maintenance, construction machinery and shipbuilding. Its output value reached RMB 108.3 billion in 2019. Representative enterprises include King Long Motor, ABB, Schneider, Taikoo, XGMA and XSI. King Long Motor leads the nation in terms of the market share and technological standard of large and medium-sized passenger vehicles. ABB and Schneider, global giants of medium- and low-voltage

power transmission and distribution equipment, boast the largest production capacity and market share in China. The scale and technological standard of Xiamen Taikoo's maintenance services for large commercial aircrafts are the highest in the Asia-Pacific region. XGMA's production capacity and technical standard of loaders and excavators are among the highest in China. And XSI's automobile roll-on/roll-off ships, developed with proprietary technology, is known as the "Xiamen type" in the international shipping market.

Xiamen's new material industry is focused on special metal materials and advanced polymer materials; it covers optoelectronic information materials, alternative-energy, energy-efficient and eco-friendly materials, and advanced carbon nanomaterials. In 2019, its output value totaled RMB 91 billion. Major higher-education and research institutions in Xiamen include Xiamen University, Huaqiao University, the Xiamen University of Technology, the Xiamen Materials Academy of CSIC No. 725 Institute, and the CAS

Xiamen Rare Earth Materials Institute. In 2019, Xiamen's modern logistics revenue totaled RMB 137 billion, and the Port of Xiamen handled

213.44 million tons of goods, ranking 7th nationally and 14th globally in terms of port container throughput. Xiamen has been approved by the State Council to build a cross-strait regional financial service center and to pilot cross-strait currency exchange, trade settlement and clearance, market access for Taiwan-funded financial institutions, and cross-strait insurance cooperation. Moreover, Xiamen leads the nation in the volumes of TWD exchange and cross-strait and cross-border RMB settlement. At

present, Xiamen has 260 licensed financial institutions engaged in banking, securities and insurance; 17 corporate financial institutions; nearly 800 financial institutions engaged in micro-loans, financial leases, equity investment, financing guarantee and Internet finance; and 50 domestically listed companies. The city has created a diversified financial service system with wide-ranging functions and a high level of operating efficiency.

Xiamen is a regional pilot city for the agglomeration of biomedicine as a strategic emerging industry of the nation. In 2019, the output value of the city's biomedicine industry totaled RMB 67 billion. The biomedicine industry in Xiamen comprises bioproducts, chemical agents, medical devices and diagnostic reagents, traditional Chinese medicine and natural medicines, and functional food. Xiamen produced the world's first hepatitis E vaccine, China's first long-acting interferon "Peginterferon", the world's third and China's

first bivalent cervical cancer vaccine, the world's first nerve growth factor formally used clinically, and China's first multi-cancer gene mutation detection kit. Moreover, Xiamen is the world's largest producer and supplier of coenzyme Q10. Representative enterprises include Sinobioway Medicine, Double Medical, Amoytop Biotech, Innovax Biotech, InTech Products, Triplex Bioscience, Kingdomway, AmoyDx, LP Pharma, Ogawa and Surgaid Medical.

#### Development Foundation

Xiamen's modern urban agriculture comprises planting, animal husbandry, agricultural and sideline products, food processing, rural tourism, and ecological leisure agriculture. The city's seed and seedling industry has developed rapidly, resulting in five major brands relating to vegetables, fruits, flowers, prawns, and materials for traditional Chinese medicine. In 2019, the processing of agricultural products continued to

thrive, and the 43 leading enterprises in agricultural industrialization reported combined sales revenue of RMB 51 billion. Leisure agriculture has become a new bright spot in Xiamen's development. Rural tourism and leisure agriculture receive more than 8 million tourists a year, and there are 11 "most beautiful" leisure villages on the "Beautiful China" program.

## Development Priorities

The focus is on the development of the digital economy, the platform economy and the intelligent economy, and proactive efforts are made to foster new forms of business and new models and to bring in and cultivate leading enterprises in the Al. Internet and blockchain industries. Moreover, substantial efforts are exerted to create a number of influential platformtype trading and service centers, to cultivate a group of professional vertical e-commerce platforms with distinctive characteristics, to facilitate the establishment of supporting service institutions for the digital economy, and to build new national-level innovation facilities for the digital economy.

#### Development Priorities

Large-scale domestic and foreign enterprises are encouraged to set up national or regional headquarters in Xiamen. They are also encouraged to establish functional headquarters in Xiamen, such as centers for operations, R&D, management, settlement,






In 2019, the reliability rate of urban power supply in Xiamen stood at 99.9898%, the second highest among the nation's 52 major cities.

#### Arbitration Institutions

Xiamen Arbitration Commission (XAC) is poised to become the regional arbitration center on the western coast of the Taiwan Strait. At present, XAC has 700-plus Chinese and international arbitrators with expertise in legal, economic, trade and other fields. For many years, XAC has ranked among the nation's top 10 in terms of the number of cases arbitrated. In the evaluation of the credibility of Chinese arbitration institutions, XAC topped the chart of the "local social influence index of arbitration institutions" and was rated as a "top 10 foreign-related arbitration service institutions".

## **Housing Security**

Xiamen has built a multi-level housing security system covering all citizens. By 2020, construction of 100,000 units of government-subsidized housing have begun, including 40,000 units of public rental housing and 60,000 units of government-subsidized rental housing and commercial housing. By April 2020, construction of 92,000 units of housing has started. The first group of government-subsidized metro community housing units is expected to be ready for occupation in September this year.

For Xiamen, attracting investment and promoting development is a strategic choice to win the future. Since the city's Investment Promotion Convention in 2019, with a focus on attracting investment and ensuring high-quality development, Xiamen has enacted a series of policies to support enterprise development, which are highly competitive on many fronts and have been welcomed by entrepreneurs and investors. All Xiamen policies on investment and incentives for enterprises apply equally to all enterprises, whether they are Chinese or foreign, state-owned or privately-held, or whether they are well-established or newcomers. These policies and incentives are fusions of "enterprise innovation, market choice, and government support" and have become part of Xiamen's first-class business environment

## **Talent Policy**

#### Top-Notch Talents

Top-notch talents, such as Nobel Prize winners, academicians of the Chinese Academy of Sciences or Chinese Academy of Engineering, and world-class entrepreneurial teams, are eligible for project

subsidies of RMB 10 million to RMB 100 million on a case-by-case basis after being approved by the relevant departments.

#### Leading Talents

- High-Level Talents Recruited from Abroad: They are eligible for a work and living stipends of RMB 1 million and be given priority in home purchases under the talent housing policy, and their children may pick a school of their choice.
- Talents on a Municipal- or National-Level Talent Recruitment Program: A stipend of up to RMB 2 million and startup financial support of up to RMB 10 million.
- Leading Entrepreneurial Talents: They are eligible for startup financial support of RMB 1 million to RMB 5 million and for subsidies of rents for 100-500 sq. m of physical space. Moreover, if the revenue of the enterprise's main business exceeds RMB 30 million, a reward equal to 1% of the actual revenue will be given.
- Outstanding Young Talents: They are eligible for a work and living stipend of up to RMB 1 million and be given priority in home purchases under the talent housing policy, and their children may pick a school of their choice.
- Prominent Educators: A relocation subsidy of up
- First-Class Medical Talents: A relocation subsidy of up to RMB 1 million and a work stipend of up to RMB 6 million.
- O High-Level Financial Talents: A reward of up to RMB 2 million
- Specially Appointed Taiwan Experts: Work and living stipends with a cumulative amount of up to RMB 1.5 million yuan (to be paid on a yearly basis).



#### Backbone Talents

"Triple-High" Enterprise Backbone Talents: Those whose annual salary is 1.5 or more times higher than the average annual salary of employees in the previous year and who have worked in the enterprise for one full year and paid their social insurance contributions, are eligible for household registration in the place where the enterprise is a legal person, provided that they choose to renew their service contract with the enterprise. ("Triple-high" enterprises refer to high-tech, high-growth enterprises with high added value.)

○ Talents in High Demand in Key Industries: Those whose annual salary amounts to RMB 500,000 or more are eligible for a remuneration stipend of RMB 150,000, while those whose annual salary amounts to RMB 300,000 or more are eligible for a remunerative stipend of RMB 100,000. Those who meet the team talent standards and whose annual salary amounts to RMB 200,000 or more are eligible for a remunerative stipend of RMB 100,000. Flexibly recruited talents whose service remuneration amounts to RMB 250,000 or more will be given a reward equal to 20% of the total amount of the personal remuneration (excluding dividends and stock option incentives) paid by the

enterprise according to the project agreement or service contract; the reward is capped at RMB 150,000

○ Young Innovative & Entrepreneurial Talents: A budgetary subsidy and living stipend of RMB 100,000 to RMB 400.000.

Specially Appointed Taiwan Professionals: A subsidy equal to 25% of the annual salary paid by the employer will be given for five years if the professional's skills fit the development orientation of a key industry in Xiamen; the subsidy is capped at RMB 120.000 per year.

○ Taiwan Financial Talents: Taiwan financial talents whose annual salary meets the relevant requirements and who serve as a mid-level or higher manager in a Xiamen-registered financial institution, large-scale financial holding company or financial research institute (think tank), are eligible for an annual stipend of RMB 80,000 for up to five years.

Social Work Professionals: Those who are recognized as national-level and Xiamen leading talents for social work are eligible for a reward of RMB 100,000 and RMB 50,000, respectively.



#### Financial Talent Plan:

High-level financial talents are classified into three categories: industry-leading talents, senior elite talents, and young backbone talents. Current and newly recruited talents in these three categories are eligible for a reward of RMB 1 million/2 million, RMB 800,000/1,600,000 and RMB 400,000/800,000, respectively. They are also entitled to other talent policy benefits.

#### Talents Recruited & Cultivated for the Cultural Industries:

Talents in the cultural industry are classified into three categories: outstanding talents, distinctive talents and excellent talents. They are eligible for a work stipend of up to RMB 1 million, RMB 500,000 and RMB 200,000, respectively, in addition to a reward of up to RMB 300,000 for innovation achievements. They are also entitled to other talent policy benefits.

#### High-Level Talent Plan for the Tourism Industry:

High-level talents in the tourism industry are classified into two categories: leading talents and senior talents. They are eligible for work and living stipends and are also entitled to other talent policy benefits.

#### Flexibly Recruited High-Level Talents (Employers):

The employer is eligible for a talent recruitment subsidy equal to 20% of the total amount of remuneration, and each individual will receive up to RMB 150,000 per year. A flexible talent recruitment base with outstanding performance is eligible for a subsidy of up to RMB 200,000. Flexibly recruited talents will receive full reimbursements for their housing rents while working in Xiamen, at the highest local rent subsidy rates for high-level talents.

#### Fundamental Talents

- Fresh university graduates who are employed or have started a business in Xiamen, and previous graduates with a bachelor's degree who are less than 45 years old or those with an associate college degree who are less than 35 years old and have consistently paid social insurance contributions in Xiamen for one to three years, are eligible for household registration in Xiamen.
- Newly recruited graduates who have settled down in Xiamen are eligible for living stipends at the following rates: RMB 50.000 for doctoral degree holders, RMB 30,000 for master's degree holders, and RMB 20,000 for bachelor's degree holders from "Double First-Class" universities or from institutions placed among the top 200 in the three globally
- recognized rankings of world universities.
- O Postdoctoral personnel at postdoctoral workstations operated by businesses and public institutions are eligible for an annual living stipend of RMB 100.000 for up to two years.
- Newly recruited fresh graduates with honors which have studied with tuition exemption at non-Fujian normal universities affiliated with the Ministry of Education are eligible for a one-off stipend of up to
- O Young people from Taiwan who have won a prize in a major entrepreneurship competition at the municipal or higher level are eligible for a housing rent subsidy of RMB 2,000 per month for up to three years.

#### Highly Skilled Talents

Highly skilled talents whose skills are listed in Xiamen's catalogue of skills in high demand and who have worked for a year are eligible for a oneoff stipend at the following rates: RMB 5,000 for technicians and RMB 10.000 for senior technicians. Validated technician training bases and skilled master's studios are eligible for a construction subsidy

of up to RMB 500.000, and highly skilled talents produced by these bases and studios are eligible for stipends at the rates for recruited highly skilled talents. Winners of the China Skills Contest and the National Awards for Technical Masters are eligible for a reward of RMB 300,000 and RMB 100,000, respectively.

## Housing Policy •



#### Housing Policy for High-Level Talents

High-level talents (Categories A+, A, B and C) enjoy substantially improved housing security, and they can now rent or purchase housing or receive free housing or supplemental housing. First, the categories of high-level talents have been expanded from A, B and C to A+, A, B and C, and the Organization Department of the CPC Xiamen Municipal Committee and the Xiamen Bureau of Human Resources and Social Security are in charge of filing and validation. Second, housing purchase subsidy rates have been substantially raised, and Categories A, B and C highlevel talents are now given subsidies of RMB 2 million, RMB 1.6 million and RMB 1.3 million, respectively, which are paid over a 10-year period. Third, housing rent subsidy rates have been substantially raised, and

Categories A, B and C high-level talents are now given subsidies of RMB 10,000, RMB 8,000 and RMB 6,000 per month, respectively. Fourth, the controlling rates for the size of housing units that talents can purchase have been raised; Categories A, B and C high-level talents can purchase a housing unit of up to 150, 120 and 100 sq. m, respectively; and the individual may resell his or her housing unit in the market 10 years after moving in, provided that he or she has worked in Xiamen for at least 10 years, and an additional 5% of the capital gain from the resale will be awarded to the individual on an annual basis. Fifth, qualified highlevel talents who have obtained talent housing can still purchase commercial housing under Xiamen's housing purchase policy.

#### Housing Security for Backbone Employees at "Triple-High" Enterprises

Backbone employees at "triple-high" enterprises are assured of housing security as they can rent or purchase housing. First, "new citizens" with no housing who are backbone employees at enterprises, newly employed graduates or regularly employed workers may apply, through their employers, for municipal-level public rental housing styled like shared dormitories, and the rents will be 30% off the market rent rates regardless of the individual's household registration, income level, marital status and age. Second, employees who are on the current lists in

the training databases of "triple-high" enterprises may purchase government-subsidized commercial housing through group allocations, and the purchase prices will be 45% of the assessed market prices. Qualified backbone employees at "triple-high" enterprises must have local household registration; there are no requirements about marital status, age or length of local household registration, but the individual must meet the requirements for income level and work experience (for example, at least one year of work experience for bachelor's degree holders).

## Sci-Tech Innovation Policy

#### Measures for Accelerating Innovation-Driven Development

- Leading enterprises in the industry receive support in spearheading major national science and technology projects and key R&D projects. They are eligible for a reward equal to 50% of the actual amount of state subsidies that they have received; the reward is capped at RMB 10 million.
- □ Encouraging the Construction of High-Standard Innovation Facilities: Provincial- and municipal-level key laboratories based in private enterprises are eligible for a subsidy of RMB 2 million, and those based at universities, research institutes, medical institutions or other legal-person entities are eligible for a subsidy of RMB 1 million. Provincial- and municipal-level key laboratories rated as excellent in performance evaluations are eligible for a reward of RMB 500,000 and RMB 200,000, respectively. Newly approved state key laboratories and state engineering research centers which are closely aligned with Xiamen's industry are eligible for a subsidy of RMB 10 million.
- © Encouraging the Establishment of New-Style R&D Institutions: Validated new-style R&D institutions are eligible for a subsidy of RMB 1 million, while validated crucial R&D institutions are eligible for a subsidy of RMB 5 million. In addition, they may also apply for subsidies of up to RMB 50 million for R&D equipment purchases.

- O Facilitating the Establishment of Sci-Tech Finance Systems: Enterprises are eligible for a sci-tech guaranteed loan of up to RMB 20 million, a sci-tech credit loan of up to RMB 5 million, and a sci-tech assurance and insurance loan of up to RMB 3 million. In addition, they can receive loan discount subsidies at a certain percentage.
- Rewards for Public Technology Service Platform Operations: Public technology service platforms which are primarily built by enterprises and operate according to market principles and which achieve an "excellent" rating in the annual performance evaluation are eligible for a reward equal to 10% of the annual technical service revenue. The reward is capped at RMB 500,000 per year.
- © Rewards for Technology Transactions: For technology contracts signed by enterprises, after being validated and registered by the competent authority, the enterprises are eligible for a reward equal to 1% of the actual annual amount of transaction if the amount is no more than RMB 30 million, and they are eligible for a reward equal to 0.5% of the actual annual amount of transaction if the amount exceeds RMB 30 million. The reward for each enterprise is capped at RMB 1 million per year.

#### Preferential Tax Policy for Tech Enterprises

- Preferential Treatment for High-Tech Enterprises: A reduced income tax rate of 15% applies. Enterprises registered in Siming or Huli are exempted from corporate income tax for the first two years, and pay corporate income tax based on 50% of the statutory tax rate for the three years thereafter. All districts offer a one-off subsidy of RMB 100,000 to RMB 250,000 to high-tech enterprises. National-level high-tech enterprises are eligible for a one-off reward of RMB 100,000.
- Pre-Tax Deduction for R&D Expenses: An enterprise may have an additional 75% deduction on top of the normal expense deduction in computing its tax liability if the expenses do not result in the creation of an intangible asset. If an intangible asset is formed, the R&D expenses that have been capitalized may be amortized before tax based on 175% of the actual

- cost of the created intangible asset.
- Technology Market (Contract) Tax Concessions: Validated and registered enterprise technology contracts are exempted from VAT. Income from a qualified technology transfer with a value of no more than RMB 5 million is exempted from income tax; if the value exceeds RMB 5 million, the excess portion is taxed at 50% of the statutory tax rate.
- Tax Concessions for Technologically Advanced Service Enterprises: A reduced income tax rate of 15% applies, and employee education expenses incurred may be deducted according to the regulations.
- Validation of High-Tech Achievement Commercialization Projects: 50% of the locally retained portion of the VAT already paid will be refunded for two years starting from the year of validation.

## Policy for "Triple-High" Enterprises **□**

#### • Encouraging Enterprises to Increase Production and Efficiency

○ High-growth enterprises receive sustained support. For "triple-high" enterprises whose local VAT and income tax payments in the current year exceed those in the previous year by RMB 1 million or more, if the excess portion is below RMB 10 million (based on the amount of tax payments in the previous year in which the conditions are met for the first time), a reward equal to 20% of the excess portion over the base amount will be offered; if the excess portion is RMB 10 million or more, a reward will be offered at the following progressive rates: 30% if the excess portion is below RMB 10 million, 40% if the excess portion is between RMB 10 million and RMB 50 million, and

50% if the excess portion is over RMB 50 million.

○ Enterprises are encouraged to increase investment and expand production. A "triple-high" industrial enterprise undertaking technical renovation is eligible for a subsidy equal to 10% of its annual equipment expenses; the subsidy for a single project is capped at RMB 10 million. A "triple-high" industrial enterprise above the designated scale whose business revenue has increased over the previous year is eligible for a reward equal to 5% of its equipment expenses upon the completion of the technical renovation; the reward is capped at RMB 10 million.

#### Enhancing Enterprises' R&D and Innovation Capabilities

- Facilitating Independent R&D Projects Undertaken by Enterprises: Qualified projects are eligible for a subsidy of up to RMB 20 million.
- Providing Greater Rewards for Technological Achievement Commercialization: Qualified enterprises are eligible for a subsidy equal to 60% of the locally retained portion of the VAT payment for two years starting from the year of the validation of technological achievement commercialization; the subsidy is capped at RMB 5 million per year.
- Supporting the Construction of Laboratories by Enterprises: Enterprises building a key laboratory are eligible for a one-off subsidy of RMB 2 million.
- Accelerating the Construction of Technological

Innovation Centers: Enterprises building a municipallevel technological innovation center are eligible for a one-off subsidy of RMB 10 million.

© Encouraging the Establishment of New-Style R&D Institutions: Enterprises establishing a new-style R&D organization are eligible for an initial subsidy of RMB 1 million; if the R&D organization is validated as a crucial one, the subsidy will be increased to RMB 5 million, and an additional subsidy equal to 50% of the costs of the purchased instruments and equipment will be paid. For a five-year period, a new-style R&D organization and a crucial one may receive a subsidy of up to RMB 30 million and RMB 50 million, respectively.

#### Raising the Level of Public Financial Support

- Encouraging Employee Stock Ownership: For personal income taxes withheld and paid by employee stock ownership platforms (limited partnerships), 80% of the locally retained portion of the personal income taxes paid by the partners will be refunded to the individual employee.
- Increasing Support for Fund Investments: For small and medium-sized "triple-high" enterprise in the category of equity investment institutions which have

incurred losses in their initial phase of operations in Xiamen, a subsidy equal to 20% of the total amount of investment losses will be given.

- Encouraging the Establishment of Industry M&A
   Funds: Xiamen and its districts may acquire a minor stake in the M&A funds of the crucial industries.
- Launching Sci-Tech Credit Loan Products: Sci-tech loans of up to RMB 5 million are available.



## Foreign Investment Policy

Foreign enterprises are encouraged to invest in Xiamen's key industries; rewards are offered to qualified enterprises whose annual value of the actually utilized foreign investment amounts to USD 10 million or more.

#### Rewards for Newly Established Foreign-Invested Enterprises

A one-off reward equal to 2% of the annual value of the actually utilized foreign investment will be given. The reward for a single enterprise is capped at RMB 20 million.

After the annual value of actually utilized foreign investment reaches USD 10 million, for two years starting from the year when the enterprise makes its first VAT payment, the locally retained portion of the corporate income tax and VAT paid by the enterprise will be refunded in full as a reward, and for the three years thereafter, a 50% refund will be made.

#### Rewards for Foreign-Invested Enterprises' Capital Receipt

A one-off reward equal to 2% of the annual value of the actually utilized foreign investment will be given. The reward for a single enterprise is capped at RMB 20 million per year.

#### Rewards for M&A Foreign Capital Receipt

Foreign-invested enterprises set up as a result of M&A are eligible for a reward equal to 2% of their annual value of the actually utilized foreign investment.

The reward for a single enterprise is capped at RMB 20 million per year.



#### • Encouraging Foreign Investors to Continually Increase Investment in Xiamen

If a foreign investor directly invests the profits distributed by Chinese domestic resident enterprises into a project encouraged by the state, he or she will

be entitled to the deferred tax policy and exempted, for the time being, from the withholding income tax, provided that the prescribed conditions are met.

#### Talent Incentive Policy

An employee who pays more than RMB 80,000 in annual personal income tax is eligible for a subsidy equal to a certain percentage of the locally retained portion of his or her income tax. Specifically, the

percentage is set at 50%, 75% and 100% for an annual personal income tax of RMB 80,000, over RMB 80,000 but below RMB 250,000, and over RMB 250,000, respectively.

#### Other

Employees whose household registration is not in Xiamen and who pay RMB 50,000 or more in annual personal income tax may purchase commercial housing in Xiamen under the same terms for personnel with Xiamen household registration.

Employees who have worked for an enterprise for three full years and paid social insurance contributions are eligible for household registration in Xiamen if they choose to renew their service contracts with their current employers.

## Preferential Policy for Taiwan Enterprises **○**



#### Economic Exchanges and Cooperation

 Taiwan construction enterprises which have been put on record in Xiamen may engage in construction activities in Xiamen within the approved scope of

O Xiamen makes efforts to create a "one city, two sets of standards" framework; the advanced and sound parts of Taiwan's comparable standards may be incorporated into Xiamen's local standards.

#### Social and Cultural Exchanges and Cooperation

- Taiwan enterprises and Taiwan compatriots may set up private non-corporate high-end nursing homes as sole proprietorships. Qualified Taiwan residents may also open clinics and medical laboratories as sole proprietorships.
- Taiwan compatriots may be invited to act as special mediators or people's jurors. Efforts will be

made to explore the possibility of establishing a Taiwan-related legal aid center in Xiamen and to build a platform for accessing Taiwan law texts and a platform for displaying Taiwan-related procuratorate matters. Moreover, Xiamen and Taiwan law firms will be encouraged to launch joint operations under pilot programs.



#### Education and Internships for Taiwan Compatriots in Xiamen

Municipal and district education departments will arrange for the schooling of Taiwan students. District education bureaus will arrange for Taiwan preschoolers and children to attend the nearest kindergartens and primary schools. A certain number of places in certain municipal Grade 1 middle schools will be reserved for Taiwan students. Taiwan students who take the High School Entrance Examinations in Xiamen and whose score meets the year's minimum requirement for entrance to general high schools will apply for a place in a provincial-level Grade 1 high school in Xiamen: they will have parallel choices of school when their applications for admission are

considered.

- O Scholarships will be set up for Taiwan students in Xiamen primary and secondary schools, and each Taiwan student studying in a Xiamen-based university is eligible for a one-off financial aid of RMB 5,000 upon enrollment.
- Based on the vocational internship stipend rates for graduates who are originally from Xiamen, Taiwan student interns will be given a monthly internship stipend and a monthly rent subsidy of RMB 500 (for a year). Taiwan students from abroad who have come to Xiamen for internships (longer than a month) will be given a one-off transportation subsidy of RMB 2,000.

#### Innovation and Entrepreneurship by Taiwan Compatriots in Xiamen

O Each year, Xiamen offers 5,000 or more employment and internship opportunities to Taiwan compatriots. Taiwan compatriots receive employment subsidies from the municipal and district governments, and they may obtain employment permits according to their personal needs.

Taiwanese teachers who have obtained a teaching credential in Taiwan can engage in music, PE or art teaching in kindergartens or general high schools in Xiamen by means of special appointment, purchase of services or short-term two-way exchanges. Xiamen seeks to attract Taiwan experts, scholars and

teachers to teach academic courses at universities and vocational colleges in the city; the academic achievements that these personnel have obtained in Taiwan may be incorporated into their work evaluation systems in Xiamen. For each Taiwan teacher recruited by a municipal public university, an annual subsidy of RMB 120,000 to RMB 150,000 will be paid from the city's public finance, and the salaries and benefits of Taiwan teachers recruited by primary and secondary schools and kindergartens are included in the public financial budget of the relevant level.

#### Housing for Taiwan Compatriots in Xiamen

- O Young people from Taiwan who are employed or have started a business in Xiamen may apply for public rental housing according to the Detailed Implementation Rules for Young People from Taiwan to Apply for Municipal-Level Public Rental Housing.
- By virtue of their Residence Permits of Taiwan Residents, Taiwan compatriots enjoy the same treatment as Xiamen residents in terms of house purchasing. Xiamen Airlines receives support from the city of Xiamen to introduce preferential measures to encourage and facilitate exchanges with Taiwan compatriots. Efforts are made to encourage Taiwan compatriots to use their Taiwan driver's licenses in Xiamen and to facilitate the swap of their Taiwan
- driver's licenses for Mainland China driver's licenses.
- O During their residence in Xiamen, Taiwan compatriots may individually partake in the basic endowment insurance scheme for employees or in the endowment insurance scheme for urban and rural residents in accordance with the same standards for Xiamen residents. Taiwan compatriots in Xiamen who partake in the unemployment insurance and work-related injury insurance schemes enjoy the same insurance treatment as Xiamen residents. Contributions paid by Taiwan compatriots to their personal housing provident fund and social security accounts may be withdrawn at one time by filing an application prior to departure from Mainland China.



## **Policy for the Private Sector ○**



#### Encouraging Innovation

A private enterprise that successfully developed its first piece or set of crucial technical equipment is eligible for a subsidy of RMB 5 million for each

innovation item. A validated provincial- or municipallevel key laboratory is eligible for a one-off subsidy of RMB 2 million.

#### Expanding Investment

Qualified municipal private undergraduate universities and vocational colleges are eligible for a one-off reward of RMB 1.2 million and RMB 800,000,

respectively. Class 3 Grade A and Class 3 Grade B private hospitals are eligible for a one-off subsidy of RMB 5 million and RMB 2.5 million, respectively.

#### Reducing Tax Burden

For qualified small-scale low-profit enterprises whose annual taxable income does not exceed RMB 1 million, only 25% of the taxable income will be taxed and a corporate income tax rate of 20% will apply. For

those whose annual taxable income is between RMB 1 million and RMB 3 million, only 50% of the taxable income will be taxed and a cooperate income tax rate of 20% will apply.



#### Easing Financing Difficulty

○ In banking evaluations, a greater weight will be assigned to the credit business for private enterprises. Due diligence and responsibility exemption systems relating to financial services for private enterprises will be established and improved. A "white list" system for renewing loans without repaying the principal is

in place to ensure seamless connections between repayment of the principal and renewal of loans.

Support is offered to private enterprise in terms of direct financing through the capital market, and appropriate rewards will be given.

#### Facilitating Enterprises' Efforts to Expand and Strengthen Their Business

○ For qualified new privately-owned industrial enterprises above the designated scale and privately-owned wholesale and retail enterprises above the designated revenue level, 50% of the increment over their local-level tax payment in the previous year will be rewarded to the enterprises for expanding their production; this reward will be given for three years. If any part of the after-tax profits distributed by a private enterprise to individuals has been converted into additional investment in the enterprise or reinvested to expand production, the locally retained portion of the personal income tax already paid on that part of the profits will be fully refunded.

 Privately-owned industrial enterprises above the designated scale which undertake a technical renovation project are eligible for a subsidy of up to RMB 10 million.

To provide institutional support for the development of the private sector, Xiamen has released the Implementation Opinions on Creating a Healthy Growth Environment for Entrepreneurs, Promoting the Entrepreneurial Spirit and Better Tapping the Role of Entrepreneurs (XM. Comm. Rls. No. [2018] 29), the Policy Measures for Further Reducing Enterprise Costs in Xiamen (XM Gov. No. [2019] 10), the Measures for Further Supporting SME Development in Xiamen (XM Gov. No. [2019] 110), and the Measures for Focusing on Enterprise Growth and Further Implementing the Business Environment Optimization Policy (XM Gov. Ofc. No. [2019] 10).



## Reward Policy for Investment Intermediaries

The practice of attracting investment through intermediaries is encouraged. Investment intermediaries who have successfully brought a project to Xiamen will be rewarded for project referrals.

#### Recipients of Rewards

Project information referrers and project promotion referrers

#### Eligibility Requirements

Eligible projects are new legal-person projects which have started production or operation in Xiamen (excluding additional investment projects, real estate projects and equity investment projects). Within four years of business registration (no later than the date for submitting applications for the reward), the project company must meet at least one of the following requirements:

Fixed-Asset Investment: The project company's fixed-asset investment in Xiamen shall not be less than RMB 200 million.

- Paid-in Registered Capital: For Chinese-funded project companies, the paid-in registered capital of the investor from outside of Xiamen shall not be less than RMB 200 million, while for foreign-funded project companies, the paid-in registered capital of the foreign investor shall not be less than USD 30 million.
- Ocontribution to the Local Economy: The cumulative amount of the locally retained portion of the corporate income tax and VAT paid by the project company shall not be less than RMB 20 million.

#### Standards of Rewards

- © Rewards for Project Information Referrers: An investment-project information referrer will be given a one-off reward of RMB 100,000.
- Rewards for Project Facilitation Referrers: An investment-project facilitation referrer will be given a reward equal to 0.5% of the base amount of the reward for the fixed-asset investment of the project, or a reward equal to 0.5% of the base amount of the reward for the paid-in capital, or a reward equal to 6%
- of the base amount of the reward for contribution to the local economy. For each referred project, the total amount of rewards is capped at RMB 3 million.
- Additional Rewards for Key Projects: A project referrer will be given an additional reward of RMB 200,000 if he or she has successfully brought a company which has been included in the list of Fortune Global 500 or the list of China's top 500 enterprises in the last three years.
